Seminar/Webinar on: A Holistic Approach to Privacy Compliance and Recent Update of Information Security Standards

Introduction	With the proliferation of smartphones, IoT devices, and social media apps, the concern of privacy is higher than ever. The management of personal data privacy, be it for HK's own PCPO, EU's GDPR, or some other data privacy regulations, is often requirements-oriented and fragmented. Data privacy is an essential element of an organization's governance and hence ought to be managed strategically and systematically like it does for quality, health & safety, and social responsibility, etc. The speaker will share how privacy is not just an IT and confidentiality issue and how it can be managed systematically. On the other hand, being the foundation of many information security and privacy management, the ISO/IEC 27001 has recently been revised to a 3rd edition. The speaker will provide the audience a high-level overview of the changes of the standard and how other associated standards are affected by these changes.
