## **Objectives of the Workshop**

This Workshop is designed to introduce the principles and practices of PIC/S GMP, AABB and FACT requirements applied in cell banks.

On completion of this Workshop, participants will be more familiar with the knowledge and skills of adoption requirements of GMP, AABB and FACT in a cell and tissue manufacturing environment, as well as donor management and product release for clinical use.

# 1. Overview of QMS in Cell Banks

- Introduction to principles of quality management in cell banks, considerations on quality assurance
- Introduction of measures to address risks such as contamination, mix-up, traceability and confidentiality
- Introduction of governance and compliance in cell banks

### 2. Donor Management

 Introduction of donor education, development of informed consent, screening of donor health, and determination of donor eligibility

### 3. Cell & Tissue Procurement

- Introduction of procurement process and control
- Review of recording and delivery of collected cells and tissue

### 4. Cell Processing & Banking

- Introduction to ISBT 128 labeling system
- Review of process for qualifying the collected cells and tissue
- Discussion on processing, testing, cryo-storage of cellular therapy products

#### 5. Product Release

- Discussion on product listing, search and reservation of a cellular therapy product
- Review of product release and distribution
- Review of clinical outcomes

# 6. Interactions with Collection Sites & Transplantation Center

- Introduction of agreements and medical notifications
- Review of collaboration in collection of cells and tissue, and assisting in transplantation
- Review of handling of adverse events
- Discussion on complaints and recalls

# 7. Critical Components for Quality Assurance

- Introduction to documentation and quality manual
- Discussion on control of deviation and non-conformity
- Review of controls on equipment and supply
- Brief the considerations for stability program
- Outline of the validation activities for both manufacturing and transportation of cells
